Monthly Activity and Community Policing Report – August 2026

We hired a new Part-Time Dispatcher for the Communications Center, Chloe Rafferty, who is a resident of East Palestine and is currently part of the dispatch training program.

Officers provided security at the first home football game of the 2026 – 2027 season as well as provided security for the Wheels of the Valley car/motorcycle/Jeep/semi event. Both events had zero incidents/injuries.

Officers participated in emergency exercises at Covington Skilled Nursing and Rehabilitation along with the East Palestine Fire Department to be better prepared for severe weather situations, fires, evacuations, active shooter events, etc.

Ptl. Gardner successfully completed the 16-hour “ARIDE (Advanced Roadside Impaired Driving Enforcement)” course in Warren, OH that trains officers to identify roadside impairment from drugs, alcohol, or both. This advanced training aims to reduce traffic crashes, injuries, and fatalities caused by impaired driving.

Cpl. Koehler successfully completed the 40-hour “AAIR (Active Attack Integrated Response)” Instructor course in Boardman, OH that improves coordination between law enforcement, fire departments, EMS, and dispatchers during active attack / shooter events.

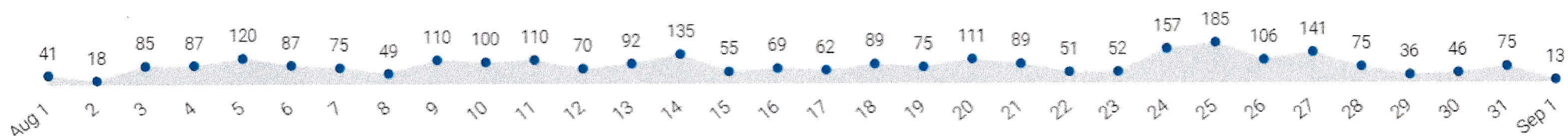

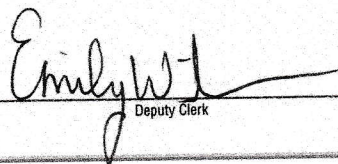

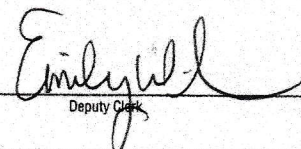
