Monthly Activity and Community Policing Report – June 2026

The department published its new Facebook page titled “East Palestine Division of Police”. The page has proven very useful in the short time since it has been active and continues to gain followers daily.

Chief Weingart and SRO Brindisi attended the tabletop emergency exercise at the East Palestine City School District Administration Office along with Fire Chief Drabick, Paramedic Nicole Drabick, Superintendent Dr. Rook, Elementary School Principal Clunen, Middle School Principal Wells, High School Principal Pavkovich, and School Communications/Marketing Allison Oltmann. This exercise ensures that all school and police/fire personnel are in sync with one another in the event of emergency situations either at or near the schools.

Officers attended funeral services for a retired EP police officer, Emery “Sonny” Coon, who recently passed away. Sonny became a part-time officer in 1981 and served the Village of East Palestine for over 33 years, retiring on his 80th birthday in 2015. We will all miss Sonny and give thanks for all his years of service.

The department is honored to have been awarded the 2026 -2027 DART (Drug Abuse Response Team) Grant through the Ohio Attorney General’s Office. The DART grant helps trained crisis peer support officers to provide 24-hour assistance to overdose survivors and their families, including treatment options, recovery support and other necessary services. Lt. Johnson and Ptl. Monteleone are both members of our support team.

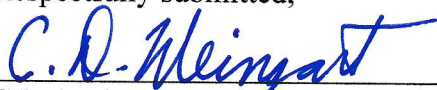

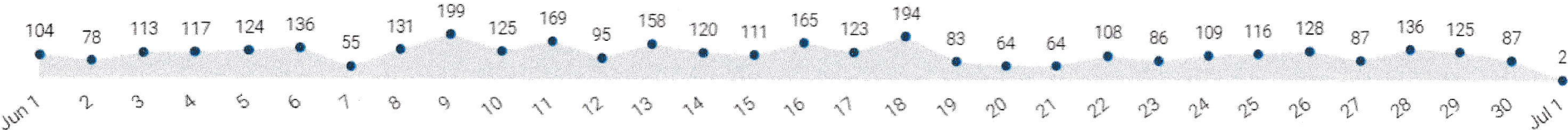
Traffic Crashes By Date

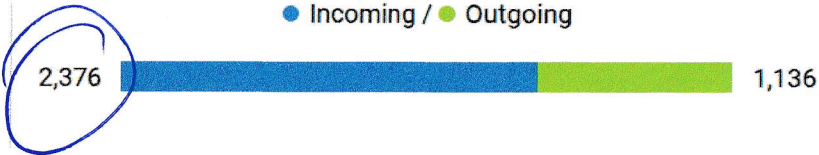

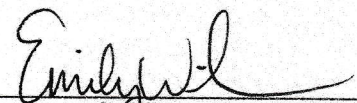

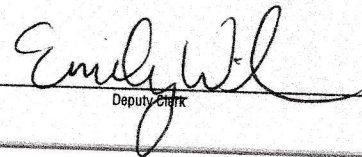
