Monthly Activity and Community Policing Report – March 2026

Chief Weingart successfully completed the 40-hour New Chief's Training in Dublin, OH from March 9th – March 13th. The training is mandated by OPOTA for all newly appointed Police Chiefs and must be completed within the first six months of their appointment to the position.

The department was recently awarded the 2026 Ohio Body-Worn Camera Grant Program and it was through this grant we were able to purchase new Axon body-worn cameras for all officers. The new Axon cameras are considered the industry standard for body-worn cameras that provide high-definition video, long 12-hour battery life, and secure cloud evidence management. The new cameras were a much-needed upgrade.

Sgt. Moore continues to teach D.A.R.E. to 6th graders at the East Palestine Middle School.

One day in March, a young girl and her mother came into the police department carrying a large stuffed panda bear toy. When the girl spoke with Dispatcher Foreman, she told him she wanted to donate the bear so that the police department could offer it to a child that needed the police but was scared. This act of kindness and compassion touched all of our hearts and we wanted to share the story with the Village of East Palestine.



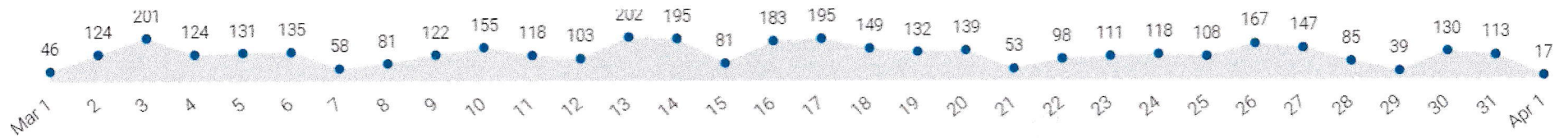
Traffic Crashes By Date
