Monthly Activity and Community Policing Report – November 2025

Chief Brown and Lt. Johnson volunteered at the Heroes and Halos Thanksgiving Dinner event. Heroes and Halos is a non-profit organization that provides awareness, education, and outreach programs to the public regarding individuals with special needs and disabilities.

Officers volunteered at East Palestine's 18th Annual Turkey Trot held on Thanksgiving Day to ensure the safety of the participants and there were no incidents.

Lt. Johnson and Ptl. Monteleone continue to work with the county Mobile Response Unit per the Drug Abuse Response Team (DART) grant to assist those who are dealing with drug dependency and related mental health issues.

Sgt. Moore completed renovations to the police department's dog kennel which included constructing a new roof over the kennel as shelter for any dogs that are being held temporarily.

Officers continued to work on the mandated Continuing Professional Training (CPT) through the Ohio Peace Officer Training Academy (OPOTA). Officers also completed the department's annual Firearms Qualifications.

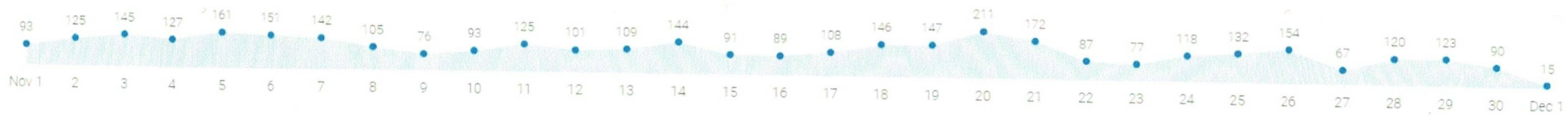

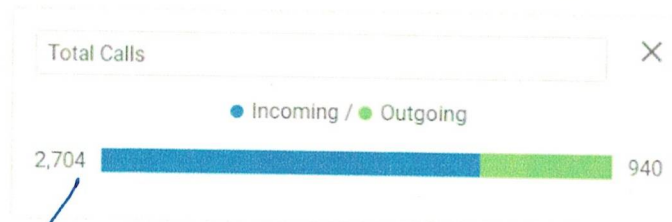
Total incoming and outgoing call durations by device.
